Part B. CV SUMMARY (max. 5000 characters, including spaces)

Javier González de Prado Salas is Associate Professor (Contratado Doctor) at the department of Logic, History and Philosophy of Science at UNED, Spain, where he was previously Assistant Professor (Ayudante Doctor, 2019-2021). Before that, he was a postdoctoral researcher at IFILNOVA, Nova University of Lisbon (2018) and a Teaching Fellow (Ayudante No Doctor) at UAM, Spain (2015-2017). He obtained his PhD in Philosophy from the University



of Southampton in 2016. Previously he completed a BS (Licenciatura) in Physics (UAM, Spain, 2007), a BA in Theory of Literature and Comparative Literature (UCM, Spain, 2009) and a master's degree in Logic and Philosophy of Science (Unviersity of Salamanca, Spain, 2010).

González de Prado works on several topics in normativity theory, epistemology and philosophy of language. His current research focuses on the norms of inquiry and on higher-order evidence. He has developed an account of higher-order defeat in terms of dispossession of reasons (González de Prado 2020 *PPR*). More generally, he has tried to provide broadly externalist normative frameworks that capture the main motivations behind epistemic internalism (González de Prado 2018 *JESP*; 2019 *PPQ*) He is also interested in different issues in philosophy of language, philosophy of science and social epistemology. In philosophy of language, he has worked on inferentialism and he has explored non-standard approaches to evaluative and normative discourse, such as expressivism and relativism (González de Prado 2018 *CJP*; González de Prado and Milic 2018). In philosophy of science, he has worked on biological normativity (González de Prado 2018 *SYN*) and, in social epistemology, on collective epistemic agents (González de Prado and Zamora Bonilla 2015, 2021).

González de Prado has over 20 publications in prestigious journals such as *Philosophy and Phenomenological Research, Synthese, Inquiry, Pacific Philosophical Quarterly or Canadian Journal of Philosophy* (15 SJR Q1 publications, 5 Q2, 1 Q3), as well as chapters in volumes edited by publishers such as Routledge or Springer. His work has been presented at numerous international congresses, workshops and academic events.

Since January 2019 González de Prado is a general editor at *Theoria: an international journal for theory, history and foundations of science*. He is part of the steering committee of the Spanish Society for Analytic Philosophy (SEFA) and is as well involved in the organizing committee of Madrid Philosophy Network (MPN). He has collaborated in the organization of several conferences and academic events, such as the 2018 conference of the Spanish Society of Logic, Philosophy of Science (SLMFCE). He has participated in 5 projects funded by the Spanish Government and, as a postdoc, in a project funded by the Portuguese Foundation for Science and Technology. He has experience teaching at undergraduate and graduate level, both in person and online, and he has supervised several master's dissertations.
